

## Continued Biosecurity Competency (CBC) Training Requirements

During 2015, the Department of Agriculture and Water Resources (now Department of Agriculture, Fisheries & Forestry) announced the accreditation and ongoing competency of entities registered for the Automatic Entry Processing for Commodities (AEPCOMM) and the Non-commodity for Containerised Cargo Clearance (NCCC) schemes.

Between September 2015 and 31 March 2016, accredited persons who received their accreditation prior to 30 June 2014 were required to complete an approved Bridging Course.

From 1 April 2016, approved and accredited persons have been required to complete Continued Biosecurity Competency (CBC) training to continue participation in the scheme.
